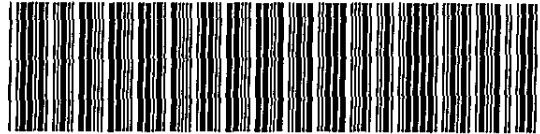

ARTICLES OF INCORPORATION
OF
SERVICES & ENERGY CORPORATION

ARTICLE I

The name of this Corporation shall be: Services & Energy Corporation

ARTICLE II

The principal place of business and mailing address of this Corporation shall be:
