ARTICLES OF INCORPORATION OF

BOWERS MASSAGE THERAPY, INC.

ARTICLE I - NAME

The name of this corporation is BOWERS MASSAGE THERAPY, INC. The principal place of business of this corporation shall be 3600 NW 43rd Street, Suite E-3, Gainesville, Florida, 32606.
