This Corporation reserves the right to amend, alter, change or repeal any provisions contained in this Certificate of Incorporation, or the management or thereafter prescribed by law. The private property of the stockholders shall not be subject to the payment of the corporation's debts in any event whatever. The corporation shall have a first lien on the shares of its members and upon the proceeds due them on any indebtedness of such members of the corporation.

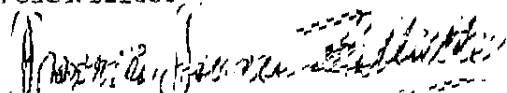
