

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

#### ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is ONE UNIT PRODUCTIONS, INC. hereinafter referred to as the "Corporation".

#### ARTICLE II; PRINCIPAL OFFICE AND MAILING ADDRESS

The mailing address and principal office of the corporation is 405 NE 157th STREET: MIAMI, FLORIDA 33162.

#### ARTICLE III: DURATION OF THE CORPORATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

#### ARTICLE IV: PURPOSE OF THE CORPORATION

#### ARTICLE V: AUTHORIZED SHARES
