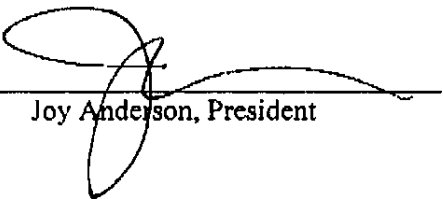
1. The Name of the professional corporation is: LANDSMAN AND DORSCH, D.P.M., P.A. ("Corporation").

2. The date of filing of the Articles of Incorporation of the Corporation was July 15, 2005 and assigned document number P05000099882.

3. The Corporation amends its Articles of Incorporation by amending Article VII. Article VII of the Articles of Incorporation is amended to change the Officers and Directors of the Corporation by deleting Terryl A. Dorsch as Director, President and Secretary and by deleting Arnold R. Landsman as Director, Vice President and Treasurer and adding Joy Anderson as the sole Director, President, Secretary and Treasurer of the Corporation.

4. Except as amended hereby, the Articles of Incorporation shall remain in full force and effect.
