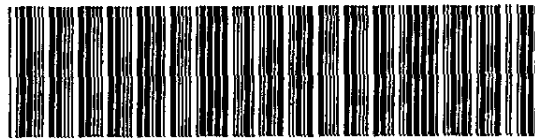

ARTICLE X – AMENDMENT



ARTICLE XI – REGISTERED AGENT


