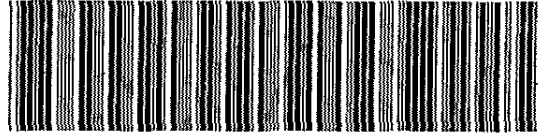

Initial Board of Directors



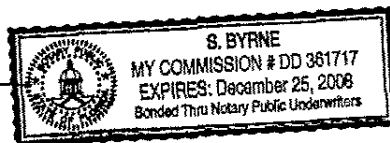
