ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a Professional Service Corporation in accordance with Chapter 621 of the Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be: YOSI TAL, P.A.

The principal place of business and mailing address shall be: 3475 North Country Club Drive, #806, Aventura, Florida 33180.

ARTICLE II

The purpose for which the Corporation is organized shall be to engage in and carry on all aspects as a real estate salesperson within the State of Florida and to do those things that are necessary or proper in connection with that practice.


