**ARTICLES OF INCORPORATION  
OF  
FLORIDA DERMATOLOGIC SURGERY AND AESTHETICS INSTITUTE, PA**

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: Florida Dermatologic Surgery and Aesthetics Institute, PA.

**ARTICLE II**

The street address of the principal office of the Corporation is: Oakland Hills Professional Center, Suite 204, 13940 US 441, The Villages, FL 32159.

**ARTICLE III**

The specific purpose for which the Corporation is organized is: clinical dermatologic surgery.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is One Thousand (1000), par value \$.001 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

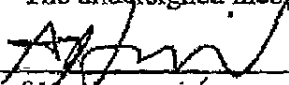

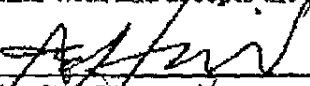
