ARTICLE I

NAME OF CORPORATION

The name of the corporation is **EAGLE EYE DRAUGHT SERVICES, INC..**

ARTICLE II

EXPIRATION DATE
07-15-05

DURATION

This corporation shall have perpetual existence commencing on the 15th day of July, 2005.

ARTICLE III

PURPOSE OF CORPORATION

This corporation is organized for the purpose of the cleaning, inspecting and service of beer products, and for the purpose of transacting any or all lawful business.

ARTICLE IV

CAPITAL STOCK

1. The maximum number of shares of stock authorized to be issued by this corporation is 100 shares of common stock, all of which shall have the par value of ONE DOLLAR AND NO/100 (\$1.00) per share, and all of which shall have the same rights and privileges.

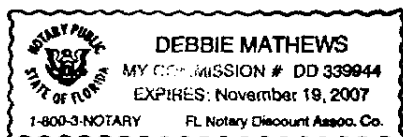


