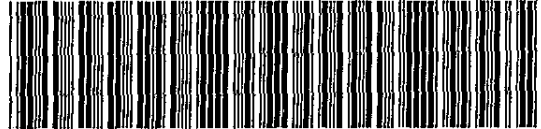

ARTICLES OF INCORPORATION

ARTICLE I. CORPORATION NAME

The name of the corporation is:

ARTICLE II. NATURE OF BUSINESS AND POWERS

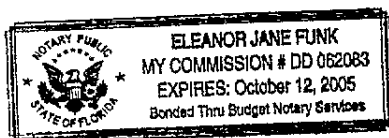

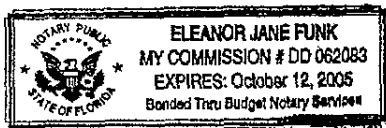
