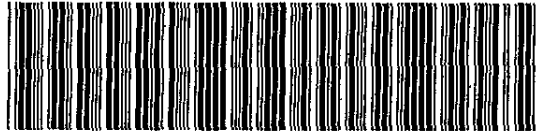

ARTICLES OF INCORPORATION

SARGEANT SERVICES, INC.

ARTICLE I. CORPORATION NAME

The name of the corporation is:

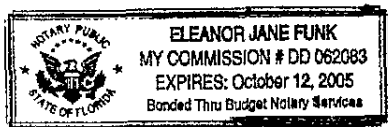
