# ARTICLES OF INCORPORATION OF

# J. CAMPBELL CARPENTRY, INC.

#### ARTICLE I - Name

The name of the corporation is: J. CAMPBELL CARPENTRY, INC.

#### ARTICLE II - Purposes

- This corporation is organized for the purpose of transacting any and/or all lawful business including, but not limited to, trim and finish carpentry and related activities.
- To act on its own behalf in all legal or equitable proceedings or suits.
