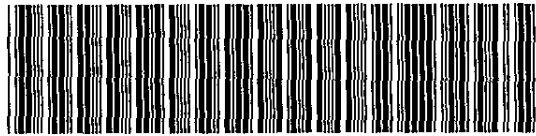

ARTICLE I

Name

The name of the corporation is Blue Moon Advisors, Inc. (hereinafter called the "Corporation").
