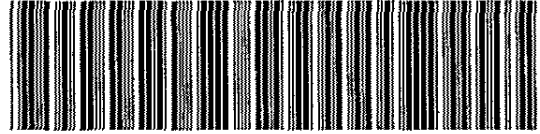

ARTICLE I - NAME EFFECTIVE DATE


