ARTICLES OF INCORPORATION

OF

Article I. Name

The name of this corporation is Merrimack Corporation ("the Corporation").

Article II. Initial Principal and Registered Office and Agent

The street address and the mailing address of the initial principal office of the Corporation and the street address of the initial registered office is 7657 Tanya Court, Tallahassee, Florida 32317. The initial registered agent is Kathleen M. Watkins.

Article III. Capital Stock

The total number of shares of stock which the Corporation is authorized to issue is: one thousand (1,000) shares of voting common stock without par value; and one thousand (1,000) shares of non-voting common stock with a par value of one dollar (\$1.00) per share.
