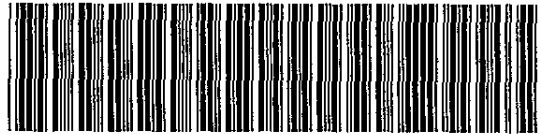



OF

ARTICLE I
CORPORATE NAME

The name of this Corporation is Mary Murphy Consulting, Inc.

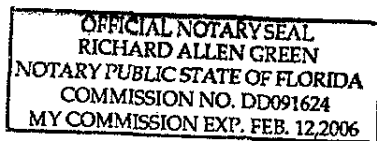
