Pursuant to Chapter 607 of the Florida Statutes, the undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

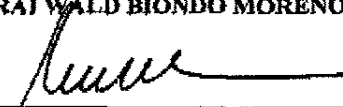
