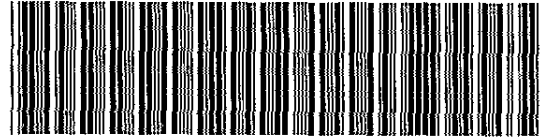

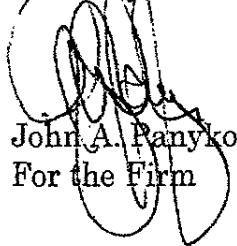

FIRST: The name of the corporation is GULF COAST COURIER, INC., a Florida corporation.

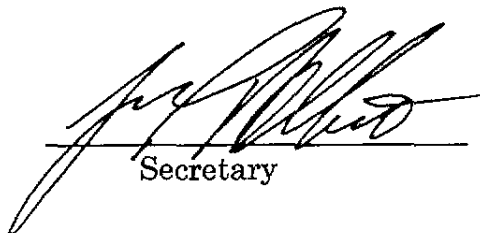

ARTICLE I – NAME —

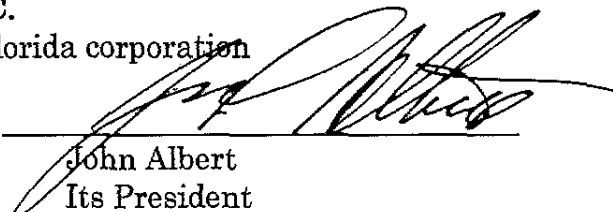
The name of this corporation is Gulf Coast Courier & Expediting, Inc.

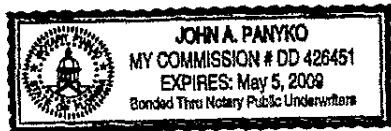

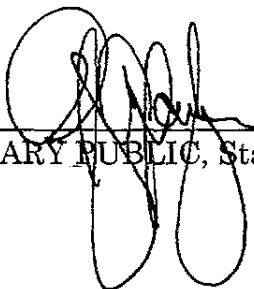
