**ARTICLES OF INCORPORATION
OF
THE MUSTARD SEED UNLIMITED, INCORPORATED**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: **THE MUSTARD SEED UNLIMITED, INCORPORATED**

ARTICLE II

The street address of the principal office of the Corporation is: 279 NW L.J. Frier Drive, Mayo Florida 32066.

ARTICLE III




