ARTICLES OF INCORPORATION FOR

ARTICLE I - NAME

The name of the Corporation shall be *DAVID A. BATES, PA*, and the mailing address for the Corporation is 17751 Castle Harbor Drive, Fort Myers, Florida 33912.
