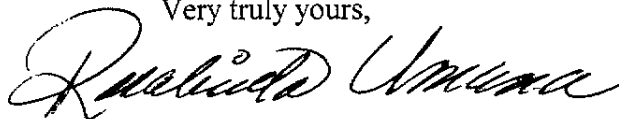

ARTICLES OF INCORPORATION
OF
NEW COLORS CONCEPTS, INC.

ARTICLE I.

The name of this corporation is NEW COLORS CONCEPTS, INC.

ARTICLE II.

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III.

This corporation is organized for the purpose of transacting any or all lawful business as a painting service.

ARTICLE IV.

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

ARTICLE V.

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
