## ARTICLES OF INCORPÓRATION

The undersigned does hereby act as incorporator in the following Articles of Incorporation for the following Articles of Incorporatio adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.
