The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article 1 - Name and Address

The name of this Corporation is R.A.P. Exclusive, Inc. The principal place of business of this Corporation shall be 501 N. Everina Circle, Brandon, Florida 33510, or such other place as may be designated by the Board of Directors.

Article 2 - Commencement of Business
