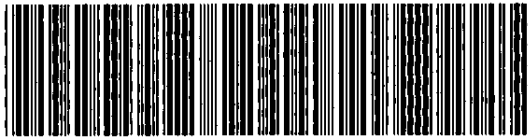

**To**

Pursuant to the provisions of Section 607.1006, *Florida Statutes*, this Florida Profit Corporation adopts the following statement to its Articles of Incorporation:

ARTICLE I: NAME

Article I is amended to change the name of the corporation and the new name is:
