Name

The name of the corporation is K-KNOTS, INC.

ARTICLE II

Duration

The corporation shall have perpetual existence.

ARTICLE III

Purpose

The purpose of this corporation is to engage in the business of Construction Consulting, and any and all business permitted under the laws of the United States and the State of Florida.

Miscellaneous

- A. This corporation shall have the following powers: All powers are as now and as are hereafter conferred upon it by law. This corporation shall continue to have all powers which the law now confers upon it, even thought the law conferring such power or powers is later amended or repealed. This provision shall be construed to give this corporation the broadest and most comprehensive powers permitted by law.

corporation may also serve the corporation in any capacity and receive compensation therefore in any form.

- F. Unless otherwise provided in the By-Laws, stockholders shall have a preemptive right to purchase their pro rate share of new stock.
- G. Unless otherwise provided in the By-Laws, cumulative voting shall not be permitted.
- H. No contract or other transaction between this corporation and any other corporation shall be affected by the fact that any director or officer of this corporation is interested in or is a director or officer of such other corporation.
- Any director of this corporation, individually or jointly, may be a party to, or may be interested in, any contract or transaction of this corporation or in which this corporation is interested.

ARTICLE IX

Amendment

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by a majority of the stockholders entitled to vote thereon, unless the directors and stockholders sign a written statement manifesting their intention that a certain amendment of the Articles of Incorporation my be amended in any other manner permitted by law.
