ARTICLES OF INCORPORATION

OF

KEITH KINARD, INC.

ARTICLE ONE - NAME

The name of this Corporation shall be KEITH KINARD, INC., with its principal place of business located at 14301 Sweat Loop Road, Wimauma, Hillsborough County, Florida.

ARTICLE TWO - DURATION

The Corporation shall have a perpetual existence, commencing on the date of filing.

ARTICLE THREE - PURPOSE
