ARTICLES OF INCORPORATION
OF

The undersigned for the purposes of forming a corporation, hereby adopts the following articles of incorporation.

ARTICLE I - NAME

The name of the corporation is "Naranjo and Miranda, Inc."

ARTICLE II - COMMENCEMENT AND DURATION

This corporation shall commence its corporate existence at the time of the filing of these Articles of Incorporation by the Florida Department of State, and shall have perpetual existence.




