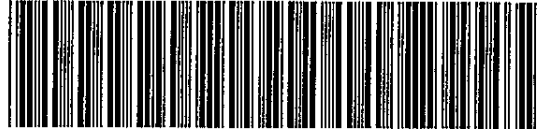



The undersigned, acting as sole incorporator of a professional association to be formed under The Professional Service Corporation and Limited Liability Company, pursuant to Chapter 621, Florida Statutes (the "Act"), adopts the following Articles of Incorporations:

ARTICLE I - NAME

The name of the Professional Association shall be NICOLE ARFARAS KERR, P.A.

ARTICLE II - PRINCIPAL OFFICE

The initial principal office of the Professional Association shall be 1709 Crossvine Court, Trinity, Florida 34655. The initial mailing address of the Professional Association shall be 1324 Seven Springs Blvd., #129, New Port Richey, FL 34655.

ARTICLE III - PURPOSE

The specific purpose for which this Professional Association is organized is to engage in the practice of law and any other lawful business activities related thereto, or in addition thereto, that may lawfully be engaged in by the Professional Association under the Act.

ARTICLE IV - SHARES

The aggregate number of shares the Professional Association is authorized to issue is Ten Thousand (10,000) shares of common stock, and the par value of each such share shall be One Dollar (\$1.00). Par value shall have no effect on the capital structure of the Professional Association.

Any issuance, transfer, alienation or ownership of the shares of the Professional Association shall be subject to the limitations and restrictions specified in the Act including, §§ 621.09, 621.09 and 621.11 thereof, as amended.

ARTICLE V - INITIAL BOARD OF DIRECTORS

This Professional Association shall have one director initially. The number of directors may be either increased or diminished from time to time as provided in the bylaws, but shall never be less than one (1). The name and address of the person to serve as the initial director of this Professional Association until the first annual meeting of the shareholder of the Professional Association, or until the one or more successors have been elected and qualify, are as follows:

ARTICLE VI – INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this Professional Association shall be located at 1709 Crossvine Court, Trinity, Florida 34655, and the initial registered agent of the Professional Association at that address shall be Nicole Arfaras Kerr. The Professional Association may change its agent or the location of its registered office, or both, from time to time without amendment of these Articles of Incorporation.


