ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopted the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME

The name of the corporation is, HEAD TO TOE ACCESSORIES, INC.

ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is perpetual.

ARTICLE III - NATURE OF BUSINESS

This corporation is organized for the purpose of sale of shoes, Handbags and other ladies accessories and Doing business as permitted under the laws of the United States and the State of Florida.

ARTICLE IV - AUTHORIZED SHARES

The aggregate number of shares that the corporation shall have the authority to issue is 10,000 shares of capital stock for the par value of \$0.01 per share, the sum of \$75.00, the par value of all of capital stock for the corporation that have been issued, shall be stated capital of the corporation at any particular time. Notice must be given by any shareholder to the President or Vice- President of said corporation not less than twenty-four (24) hours prior to the time set for the holding of a shareholder's meeting for the election of directors that said shareholder intends to cumulate his vote at said election.

ARTICLE XI - SECTION 1244

This corporation and the shareholders hereof shall be Section 1244 of the United States Internal Revenue Code.
