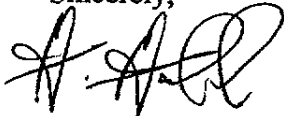

ARTICLES OF INCORPORATION  
OF  
GADAH GROUP, INC..

ARTICLE I - NAME AND MAILING ADDRESS

The name of this corporation is Gadah Group, Inc. The mailing address is 6950 Magellan Way, Sarasota, Fl. 34243.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV - POWERS

This corporation shall have all the corporate powers enumerated in the Florida General Corporation Act.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue 100 shares of common stock having a par value of one (1) dollar per share.

ARTICLE VI - PREEMPTIVE RIGHTS

#### ARTICLE VIII – INITIAL BOARD OF DIRECTORS

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors, and the shareholders.

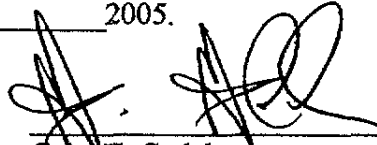
ARTICLE XII- AMENDMENT

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

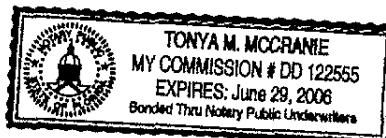

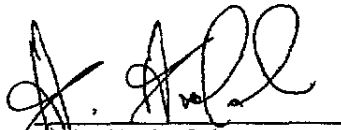
