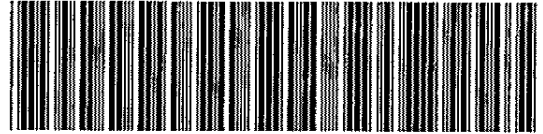

ARTICLES OF INCORPORATION

of

ATLANTIC CERTIFIED HOME INSPECTIONS, INC.

The undersigned, for the purpose of forming a corporation under the laws of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation is **ATLANTIC CERTIFIED HOME INSPECTIONS, INC.**

ARTICLE II
DURATION

This corporation shall have perpetual existence.

ARTICLE III
PURPOSE
