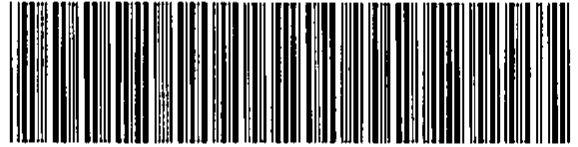



Business Purchasing Contract

Agreement made today, Monday March 15th, 2020, between Anthony A. Honarvar (Seller) and Amy Jo Sykes (Buyer).

- 6- If and only If, Amy Jo Sykes and General Punchout and warranty, Inc. do not pay Anthony A. Honarvar for Six (6) weeks, Amy Jo Sykes agrees that the Company, General Punchout and Warranty inc., ownership will go back to Anthony A. Honarvar.
- 7- General Punchout and Warranty, Inc., can use the office with all it's equipment for time being, and till further agreement.


Instrument as Entire Agreement

Effect of Agreement


This agreement shall inure to the benefit of and be binding on the heirs, executors, assignees and successors of respective parties.
