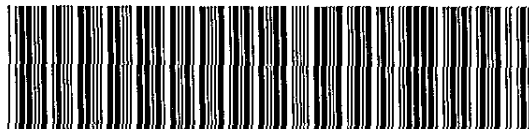

**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME**

The name of this corporation is Heisenberg, Inc.

The holders of common stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, shares of common stock of this corporation which may be issued from time to time for money, property or past services in addition to the stock authorized and issued by the corporation. #### **ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT**

The initial Board of Directors shall consist of one (1) member. The number of directors may be increased from time to time by vote of the stockholders, but in no case shall the number of directors be less than one (1) nor more than three (3).

The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

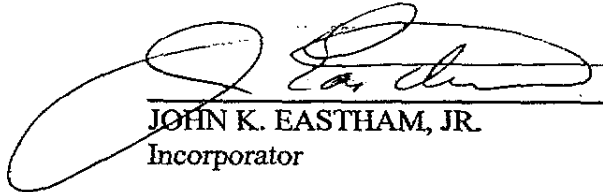
