# ARTICLES OF INCORPORATION OF Heisenberg, Inc.

# ARTICLE I - NAME

The name of this corporation is Heisenberg, Inc.

# **ARTICLE II - DURATION**

This corporation shall have perpetual existence.

### **ARTICLE III - PURPOSE**

#### ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT
