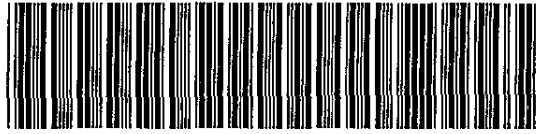



The undersigned, for the purpose of forming a professional corporation under Chapters 607 and 621, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation is Ersilia Braun, P.A.

ARTICLE II

The duration of the corporate existence shall be perpetual. The date of corporate existence shall be the date on which these Articles are executed by the undersigned incorporator.

ARTICLE III

The general purpose of this corporation shall be the furnishing to the general public of services in connection with the purchase and sale of real estate, real estate brokerage, and financial services related to real estate. 


