

ARTICLES OF INCORPORATION OF MANOLY'S, INC.

TATILARASSECTION IN 25 The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I NAME AND PRINCIPAL ADDRESS

The name of the corporation shall be: MANOLY'S, INC., and the mailing address of the corporation shall be: 1860 NW 24TH Court, Miami, FL 33142.
