In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Debbie Ursin, MSW, LCSW, P.A.

ARTICLE II

The street address of the principal office of the Corporation is: 505 Park Avenue North Suite 201, Winter Park, FL 32789.

ARTICLE III

The specific purpose for which the Corporation is organized is to provide psychotherapy, counseling, coaching, teaching, and any and all lawful services provided by Licensed Clinical Social Workers in accordance with the Laws of the State of Florida.
