The undersigned incorporator files these Articles of Incorporation in order to form a corporation under the Florida General Corporation Act.

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

DURATION OF THE CORPORATION**

The existence of this corporation shall be perpetual.

**ARTICLE III
CORPORATE PURPOSE**

PRE-EMPTIVE RIGHTS

This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares pre-empted within thirty (30) days of receipt of a

notice in writing from the corporation, stating the price, terms and conditions of the issue of shares, and inviting the shareholder to exercise his, her, or its pre-emptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

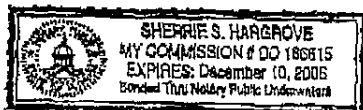


