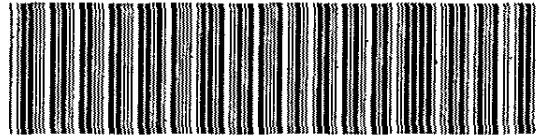

Article I
Identification
