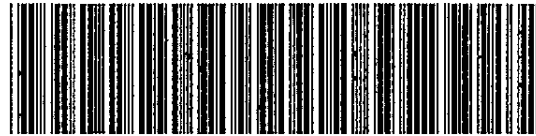



Article III Purpose

The corporation is formed to engage in every phase and aspect of wholesale & retail agricultural products & services, transcription services and any other area to provide a full range of services. In addition, the corporation may invest the funds of the corporation in real estate mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of home & building maintenance and improvement service to customers.

Article IV Terms of Existence

No stockholder of the corporation may sell or transfer stock in the corporation unless the sale or transfer has been approved at a stockholder meeting especially called for that purpose.

Article X Indemnification

The corporation shall indemnify its directors, officers, employees, and agents to the full extent permitted by law.


Article XI Amendment

Article XII Effective Date


