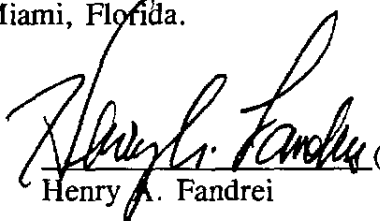

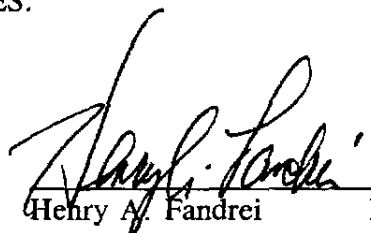
ARTICLE IX
