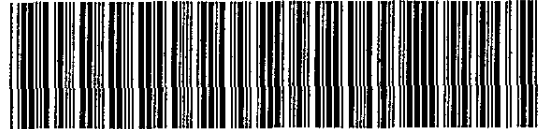



We, the undersigned, hereby associate ourselves together for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the statutes of the said State of Florida.

The initial officers shall be Emily Feliciano as President and Victor Feliciano as Secretary-Treasurer.



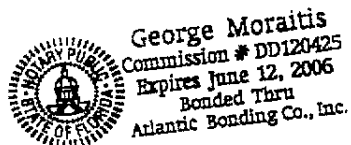
