ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is SOUTHWEST RESORTS, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of operating a vacation resort.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 7500 shares of \$1.00 par value Common Stock, which shall be designated as "Common Shares."

ARTICLE IV - DESIGNATION OF SERIES

Preferred Shares may be issued from time to time in series. All Preferred Shares shall be of equal rank and identical, except in respect to the particulars that may be fixed by the Board of Directors herein. - 3. The redemption price or prices, if any, for the shares of each, any or all series;
- 4. The obligation, if any, of the corporation to maintain a sinking fund for the periodic redemption of shares of any series and to apply the sinking fund to the redemption of such shares;
- 5. The rights, if any, of the holders of shares of each series to convert such shares into Common Shares and the terms and conditions of such conversion.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1904 East Busch Boulevard, Tampa, Florida 33612, and the initial Registered Agent of this corporation at that address is Patrick F. Sprague.

ARTICLE VII - INITIAL BOARD OF DIRECTORS
