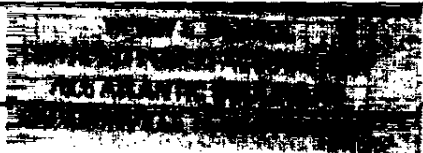

ARTICLE I - NAME

The name of this is HOMEPRIDE CARPET CARE, INC.

ARTICLE II - DURATION


