ARTICLES OF INCORPORATION

SECHLINGY OF STATE TALLAHASSEE, FLORIDA

The undersigned does hereby act as the incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.
