**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is J. DYER, INC., and the principal address and principal place of business is 107 WOODBURN COURT, SAFETY HARBOR, FLORIDA 34695.

ARTICLE II - REGISTERED OFFICE AND AGENT
