ARTICLES OF INCORPORATION

ARTICLE I - NAME - LOCATION

The name of this corporation is INSYNC COMMUNICATIONS, INC., located at 900 N.W. 5th Avenue, Fort Lauderdale, FL 33311.

ARTICLE II - DURATION

This corporation shall exist perpetually, commending on the date of execution and acknowledgment of these articles.
