The undersigned incorporator, EDWARD H. HART, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is NET CENTRIC SOFTWARE, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 4960 Highway 90, #130, Pace, Florida 32571.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK

ARTICLE IX - COMMENCEMENT OF CORPORATE EXISTENCE

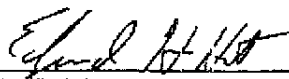
The date for commencement of this corporation's existence shall be the date these Articles of Incorporation are filed with the Florida Secretary of State.
