## ARTICLES OF INCORPORATION OF

N & S CONCRETE, INC.



#### ARTICLE I - NAME

The name of this corporation is N & S CONCRETE, INC.

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually.
